Please be mindful that most backflow assemblies can be tested at any time as long as it is before the May 15th deadline since they are always connected to running water source.

Backflow assemblies are NOT required for sprinkler systems "ONLY" connected to Dalton Gardens Irrigation Dist. or Schloss Irrigation systems, or other non-potable/drinking water sources, i.e. wells or ponds.
