**WATER FEE SCHEDULE**

**SCHEDULE 1**

**METERED RATES**

Base rate (& excess water charge if applicable) is billed quarterly – January, April, July & October each year.

**Base rate is billed in advance of each quarter and excess water charges, if applicable, are billed in arrears of the quarter used.**

Service	Monthly Gallon Allotment	Fee
Residential	10,000 gals per month	\$78.00
Commercial	10,000 gals per month	\$123.00
Excess	over 10,000 gals per month	\$1.00/1,000

**NOTE:** Users which are considered in more than one of the classifications above will be charged the highest rate commodity charge of their use classification for all water use.

**SCHEDULE 3**

**HOOKUP FEES**

Includes labor and materials and Dalton Water installs service.

Standard service hook up fee schedule (by size) complete from main to adjoining property line, including meter, meter box, and setting:

<b>Meter Size:</b>	
¾ inch	\$3,500
1 inch	\$4,000

Any structure designed to house one family shall be defined as a “dwelling unit.”

Where the service hookup is other than standard, costs may be calculated by the Dalton Water to represent actual costs.

**Hookup Fee is a separate fee paid at the time of and in addition to the Membership/Multi-User Fee.**

Hookup may be made by an approved contractor to Dalton Waters specification and approval with proof of insurance provided prior to work.

**NOTE:** Any additional Installation costs incurred, exceeding the hookup fees paid at time of application for membership/multi-user service, such as permit fees, compaction testing, road boring, and asphalt/concrete repair will billed after water service is installed and must be paid before the water service is activated.

**SCHEDULE 7**

**PRIVATE FIRE SPRINKLER, FIRE HYDRANT AND/OR HOSE SERVICE RATES & CAPITALIZATION FEES**

**Applicability:** To all customers who have private fire sprinkler system, fire hydrants, and/or hose service connection for firefighting purposes.

**Rates:** For unmetered service through a separate line for firefighting/private fire sprinkler system purposes:

Service Size	Tap Fee	Connection Fee	Annual Rate
6 inch	At Cost	\$1,500	\$150.00
8 inch	At Cost	\$1,500	\$200.00

Connection fee is to be paid to Dalton Water at time of application.

Property owner is to provide proof of insurance.

Provided that if the installation of a private fire service shall require and extension of the existing mains of the Association, the cost of such extension shall be borne by the members per tap size which will be paid at an additional charge.

All private fires services shall be equipped with sealed gate valves.

All private fire services shall be equipped with backflow assemblies that attached to a fire hydrant.

Meters may be placed on fire services by the Association at any time; however, metered rates will not apply unless improper use of water is disclosed; and if such be the case, usage will be billed to the consumer based on the Commercial rate schedule.

**NOTE:** Any additional Installation costs incurred, exceeding the hookup fees paid at time of application for membership/multi-user service, such as permit fees, compaction testing, road boring, and asphalt/concrete repair will billed after water service is installed and must be paid before the water service is activated.
